Job Scope comments: This facility will consist of five multi-use courtrooms, along with support spaces, and totals approximately 77,400 gross building square feet. The courthouse will be two stories in height, above grade with a basement level containing the main In-custody holding area and a below grade vehicle sallyport. The structure is a steel moment frame system on spread footings. Exterior finishes include aluminum and glass curtain wall, veneer brick, EIFS, and metal panels. A glass curtain wall along the south face of the building provides natural daylight to most public areas with a deep roof overhang for shading.
